INSURANCE CANCELLED!

For the past two days I have had the distinct displeasure of informing several people in my office that, due to the Affordable Care Act, their current health insurance has been cancelled. When we originally received this notification, we asked our insurance broker to get a bid for insurance that would comply with "Obamacare". The proposal that came back to us was incredible.

For years we have struggled to find insurance that would cover not only our W-2 employees, but our 1099 Independent Contractors as well. I personally have had to be self-insured for many years and this is not an inexpensive form of health insurance. Finally, last year, we found a company that would offer insurance coverage to everybody. Well, it was good while it lasted. Due to doubled premiums, no co-pays or prescription co-pays and zero coverage until the \$6350 deductible is met, we cannot provide replacement coverage for our 1099 Independent Contractors.

We are reapplying for a policy for our W-2 employees. All of this has happened with about one week's notice. So far, there has been nothing "affordable" about it! If you are experiencing anything like what we are experiencing, I urge you to contact your Congressman! It will take the action of citizens to right this ship—the sooner the better, too!

Update—One Week Later: On December 3rd I received a phone call from our insurance broker telling me that our current insurance carrier had reconsidered and would now like to renew our existing policy, including coverage for our 1099 Independent Contractors. There would only be two changes: Our premium would go up \$3.00 per month, and our deductible would be reduced to meet ACA guidelines (about a \$2500 reduction). Joyous news! We feel that this is probably only a one year reprieve, depending on how this all pans out, but at least we are insured and keeping a few dollars in our pockets for now. -Anne McCawley

Owner Statement Changes

We will all see some changes in our monthly statements next year. All of the cities in the valley are continuing their drive to increase revenue from the sales tax, the so-called, "privilege tax".

The latest push is to classify income from any source as taxable income. This impacts us directly as the cities now require us to call forfeited security deposits "income" even when those deposits are used to repair or maintain the properties.

For many years we transferred forfeited deposits directly into vendor payments, leaving the deposits out of the "income" column. We have been fighting this issue for years. From here forward, forfeited deposits must count as income, and then be expensed as repairs.

The bottom line impact is not significant, but the company wants owners to know why the statements will look different.
